First things first

SEVIS Registration: On the notecard, please provide the following information:

US Address/Phone

- If you are in a dorm, just add dorm name and PO Box in mailroom
- If you have a US phone, please provide that.

Expected Program End Date/Major

 Not your graduation date, but the month/year you are expected to take your last classes.

Visa Basics

Key documents to travel with and keep in a safe place.

F-1 Visa/Passport

Located in your
 passport and given to
 you by the US
 Embassy in your
 home country, except
 if you are Canadian.

Form I-20

- Document to keep updated and with you anytime you travel.
- The "travel endorsement" on the back needs to be signed before traveling.
- Valid for one year.

I-94

Shows your arrivals and departures in the US.



Enrollment Requirements

Department of Homeland Security has strict guidelines for F1 Students. These are LEGAL requirements and important to follow.

Enrollment

- Stay Enrolled full-time (12 credits)
- Only allowed ONE (1)
 online class PER
 SEMESTER, toward
 your major
- Get approval before dropping below fulltime or asking for temporary leave

SEVIS Updates

- Report address changes
- Academic changes, including graduation or program end date within 10 days of the change

Maintain Academic Progress

- Maintain a 2.0 or higher
- Make normal progress toward your degree
- If you are looking toward a graduate degree here, we need to talk;)

Health Insurance

The state of Massachusetts REQUIRES ACA (Affordable Care Act) compliant insurance. You DO NOT want to be without. There are financial implications down the road if you try to use something different.

University Health Plan

ISO and other "cheaper" insurances

Employment Rules

Department of Homeland Security has strict guidelines for F1 Students. These are LEGAL requirements and important to follow for employment.

On-Campus Employment

- Only allowed to work on campus a max of 20 hours per week during school
- Unauthorized work can lead to visa termination
- You need a US Social
 Security Number

Off-Campus Employment

- CPT (Curricular Practical Training) or internships
- MUST be related to your major
- MUST be listed on your I-20 BEFORE you actually start working
- OPT is for postgraduation

Come See Me

 Make an appointment with me to discuss any internships or work opportunities to ensure you are following regulations.

Campus Conduct, Safety & Rights

Be a Good Human

- Any on campus/off campus infractions or run ins with the law can affect you and your immigration status
- Avoid political protests
- Avoid posting anything on your social media you wouldn't want
 Grandma to see

Safety

- Report safety
 concerns to Student
 Life and/or Public
 Safety
- Carry your I-20 and
 Passport when you go
 out to bars off
 campus

You Have Rights

- You have the right to remain silent and consult an attorney
- Never sign documents without legal advise
- You can always call me in an emergency
- What's App.

Driving & Local Laws

Driver's License

- You are only allowed temporary access to driving with a license from a different country
- Some licenses are recroprical
- No drinking and driving--call someone.

Laws

- Follow traffic laws strictly
- Keep registration and insurance updated
- The state of Mass requires a minimum amount of auto insurance
- Please understand it is illegal under
 FEDERAL law to possess marijuana

Public Transportation

- Bison Shuttle
- Uber
- Local Bus to Worcester
- Train in Worcester

Taxes
